# VPMIA Board of Directors Meeting Minutes

Vice president Ellis McKinney opened the meeting with the pledge of allegiance just after 9am.

Enough Board Members were present to establish a quorum.

Vice President McKinney swore in the new District 1 Director Mr. Terry Ganey from Prince William County. Mr. Ganey fills the Directors position that was vacated by our current Treasurer Mr. Dennis Hart.

## Reports of Officers

### Secretary:

The draft reports received by the Secretary were posted on the VPMIA website by our webmaster so that everyone had access to them. Mr. Adkins commented that he liked the way the report looked. (Thank you sir!) There was a motion to accept the draft reports and a second with a unanimous vote of yea.

### Treasurer:

Mr. Dennis Hart spoke briefly on his written report. The details of his report are included in the final minutes. There was no discussion.

### Executive Secretary:

Mr. Chris Martin was not present but had provided a report. His report is part of the final report. Mr. Robert Adkins stated that he had concerns with the number of members that had not paid their dues. He asked if we were doing anything to address this issue. Mr. Anthony McMahan explained that the District Directors were the ones that should be contacting members that were not current. Mr. Adkins asked if we were sending out lists of names to the Directors of people to contact. Mr. McMahan said that we need to do that again and Mr. Chris Martin maintains that list so we need to have him send out the lists to the directors again. Mr. Rick Witt suggested that the Directors contact the Building Official of the localities to try and bring members current in their locality. Mr. McMahan mentioned that as part of Spring SOI registration he confirmed membership status but beyond this effort and any effort made by Mr. Martin, no one had made an effort to contact members. Mr. Adkins stated that we need to get the list out to the Directors so the organization does not shrink. All agreed that this needed work. Also brief discussion about reaching out to associate members. Since the meeting Mr. Martin has sent out member information to the District Directors.

## Standing Committees

ICC – Kris Bridges. Mr Bridges has provided a report. The report is part of the final meeting minutes.

ICC – Region 7. Mr. Rick Witt from Chesterfield County gave a report at the meeting. Meeting scheduled for the Thursday and Friday, last week in September. Discussions will be held about code changes for Las Vegas. Mr. Witt recommends that if you would like to receive support from the region to attend the meeting and speak about them at the meeting and also send them to Don Mock, Region Chair for placement on the agenda. These will be discussed Thursday. Also ICC board interviews will be done to see who the region will/will not support. An ICC bylaw change will be discussed at the meeting to possibly eliminate section seats and make them region seats. This would limit each region to 2 members on the board, or 2 from 1 state. Mr. Witt feels that this is a bad idea and feels that it would be in VPMIA's best interest to be against this change. Mr. Witt announced that after the September meeting he will be retiring and VPMIA will need to find someone to replace him in his capacity as liaison to region 7. Mr. McKinney thanked Mr. Witt for his service to the organization for many years in this role.

DHCD – Sandi Morris. Ms. Morris has provided a report and it will be attached to the final minutes. Ms. Morris noted that DHCD is not waiting a year to begin code changes as they have in previous years. DHCD has started the 2018 Code Change Process. Check the DHCD website for the meeting dates and times. Ms. Morris shared that DHCD will be running a pilot of having interactive distance meetings with Adobe Connect. This will allow you to connect at your desktop. DHCD hopes this will increase participation and attendance at meetings. Mr. Witt spoke briefly about the special workgroup for Fire Code Changes. He is part of that workgroup. Mr. Witt spoke briefly about the School Safety sub-workgroup that is reviewing proposed code changes about security devices that will prevent intruders. Some discussion about other non-approved methods that have been seen across the state. Ms. Morris talked about bringing in Jarrod Henderson from California. He is DHCDs recognized leader in photovoltaic. Jarrod is a photovoltaic expert. He is a primary contributor for ICCs codes on photovoltaic. Jarrod was brought in to teach a one day class on inspections for solar. DHCD also plans to bring someone in to teach a class on photovoltaic plan review. Ms. Morris spoke some about the DHCD Essay contest. She thanked VPMIA for their contribution to the essay contest. The group had questions about who was eligible to apply. Ms. Morris clarified that college students, high school students, enrolled in a college OR trade school program would be eligible for the scholarship. Mr. James Anjam asked if VCEC had done anything lately. Ms. Morris said that they need to meet. Ms. Morris encouraged everyone to apply for the Building Safety Month contest.

DPOR – Mr. Redifer from Newport News provided a report. That report is part of the final minutes.

Advertising/Yearbook – Anthony McMahan. No report. See feedback from April SOI in the final minutes.

Auditing – Ellis McKinney. Audit went well. Mr. McMahan provided all paperwork electronically and I was able to review this before we met. Everything was in order for the transfer of the books to the new treasurer. Mr. McMahan is detail oriented and did a really good job as Treasurer.

Bylaws – Dustin McLehane. No Report.

Awards – Randy Bowman. No report.

Certification/Education – Vacant. Anthony McMahan provided an interim report. This report is part of the final minutes. Mr. McMahan offered to fill the Education Chair position if the President and Board had no objections. The members present welcomed the help however deferred the final decision to the President as it is his responsibility to fill the committee chair positions. There was discussion about trying to see if Skip would come back and fill the Education Chair roll. Randy Pearce said he is going to check with his supervisor to see if he could devote more time and help out in this capacity. Daikin's trainers enjoyed the Spring SOI and are interested in coming back and doing training for us again. Mr. Steve Fox with Hydrocorp has offered to come and provide some training for us on backflow prevention. Mr. Fox is ASSE 5000 series instructor. Mr. Fox's information is attached to the final minutes.

Information Technology – Jane Kim. Secretary laptop has been replaced. Constant Contact must be renewed. Jane said she would talk to the Treasurer and pay the bill for this. Jane has requested an air card to facilitate the ability for her to work on the website while at work. Currently Fairfax County will not allow connection to the server to make updates and changes on their network. The board discussed the matter and asked Jane to research the matter and come back with details on what the cost would be.

Nominating – James Anjam. No Report

Legislative – Ron Clements. Mr. Clements provided a report and it is part of the final minutes. Mr. Clements hit some highlights for some of the bills.

Plumbing/Mechanical/Fuel Gas – Richard Grace. Mr. Grace provided a report. The report is a part of the final minutes. Mr. Grace touched on some of the current changes and where they were in the process. He explained how the committee was working via email, and that seemed to be working well. There was a discussion to propose code modifications for order of precedence to make sure non-safety items did not overrule safety items. Mr. Grace let everyone know if you would like to be on the committee contact him.

Time & Place/School of Instruction – Bob Adkins. Graves is a go. We are headed back to Virginia Beach in April of 2020.

BCAAC – Randy Pearce. No new report since the last report provided. Lively discussion on proposals on changes to the certification standards. Should the number of hours change from 16 to 20? Possible accessibility training requirements. Much of the discussion stemmed from the VBCOA meeting on March 31<sup>st</sup> ( <https://vbcoa.org/wp-content/uploads/2019/06/March312019APPROVED.pdf> ). Also announcement of Master Code Professional certification at the Virginia State Level. Requirements forthcoming. No release date.

Building Safety Month – Mark Grimmell. No Report.

VCEC – Dustin McLehaney. No Report. Committee needs to meet (James and Sandi).

VBCOA – Rick Witt. Annual meeting September 21-23 in Virginia Beach at the Hilton. See the VBCOA website for the details.

### **Code of Honor Scholarships application deadline is August 9 for those seeking aid to attend PCH**

It's intended to support participation in the Public Comment Hearings (PCH) held October 23-30, 2019 in Las Vegas and to help ensure that the I-Codes reflect the consensus view of officials at all levels of government by providing funding to Governmental Member Voting Representatives seeking to attend and participate in the PCH. Currently the program includes the following categories:

- **Architect Leaders** – Governmental Member Voting Representatives who are licensed architects (financial support by AIA).
- **Emerging Leaders** – Governmental Member Voting Representatives who have served their jurisdiction between 4 and 9 years.
- **Future Leaders** – Governmental Member Voting Representatives who are new to the profession, serving less than four years.
- **International Leaders** – Governmental Member Voting Representatives who reside outside of the United States.
- **Match Scholarship** – Governmental Member Voting Representatives who have a 50% financial match from their Code Council Chapter, jurisdiction or personal. [Click here for ICC Chapters](#).
- **Small Town Leaders** – Governmental Member Voting Representatives whose city or county population is 50,000 or less.

## DHCD Report (Updated 6-18-2019)

- The public hearing for the proposed phase of the code change process is scheduled for Monday, July 22 at 10:00 a.m. and will end upon the completion of testimony. It will be held at the Virginia Housing Center, 4224 Cox Rd, Glen Allen, VA, 23060. There will also be another public hearing held during the final regulation phase.
- At their March 18, 2019 meeting, the Board of Housing and Community Development adopted emergency cooling regulations within the Virginia Maintenance Code. The Governor has approved the emergency regulations and the change is effective immediately. The relevant code provision is enforceable May 15.
  - The emergency regulations alter Chapter 6 of the Virginia Maintenance Code, Section 602.4 Cooling supply, to lower from 80 to 77 degrees Fahrenheit, the maximum allowed temperature, where cooling is provided, in R-2 multifamily residences (the Virginia Administrative Code reference is 13VAC5-63-540 B 5). This provision is enforceable from May 15 until October 1.
  - The emergency regulations are effective for an initial period of 18 months. During this time, the Board of Housing and Community Development will work with stakeholders to solicit input and develop permanent regulations regarding this issue. Please contact the State Building Codes Office at [sbco@dhcd.virginia.gov](mailto:sbco@dhcd.virginia.gov) if you have any questions.
- The DHCD website has a new look and everything related to building fire regulations/code academy information can be found when clicking on "CODES".
- Thomas King joined the State Building Codes Office as a Code & Regulation Specialist in June, transferring from the Division of Operations within DHCD. Thomas is a US Navy veteran and brings with him valuable leadership, problem solving and training development and delivery skills. He will be working in code development and assisting with other SBCO technical support services.
- Effective February 18th, the new and improved cdpVA is open for submission of code change proposals for the 2018 Code Development Cycle for the following regulations:
  - Uniform Statewide Building Code
  - Statewide Fire Prevention Code
  - Amusement Device Regulations
  - Certification Standards
  - Manufactured Home Safety Regulations
  - Industrialized Building Safety Regulations

- NOIRAs for the USBC, SFPC, VADR, VCS, MHSR and IBSR were published on April 15th in the Virginia Register of Regulations, with a comment period that was open until May 15<sup>th</sup>. At their March 18<sup>th</sup> meeting, the BHCD also approved a revised schedule for the 2018 code development cycle and it has been posted on cdpVA.

- The first round of workgroup meeting for the proposed regulation phase of the 2018 code development cycle wrapped up on June 5<sup>th</sup>. Each workgroup is tentatively scheduled to meet one more time before the end of August. Workgroup meetings schedules and information are posted on cdpVA:

- July 24, 2019 Workgroups One & Two Meeting
- Aug. 14, 2019 Special Workgroup (Fire Code Edits) Meeting
- Aug. 21, 2019 Workgroups Three & Four Meeting

**WORKGROUP ONE** - Administrative provisions of VCC, VMC, VRC and SFPC regulations; VADR/ADTAC regulations (amusement rides); VCS/BCAAC (certification requirements; IBSR (modular buildings); MHSR (manufactured housing); Related Laws; Manufactured Housing Licensing and Transaction Recovery Fund Regulations and, other state agency's regulations for functional design.

**WORKGROUP TWO** - Technical provisions of VCC, VMC, VRC and SFPC (IBC, IFC, IEBC and IPMC and other model codes).

**WORKGROUP THREE** - Residential provisions of the VCC, including IRC model code, trades and energy.

**WORKGROUP FOUR** - Technical trade provisions of the VCC, including IPC, IMC, IFGC and NEC.

**SPECIAL WORKGROUP (FIRE CODE EDITS)** - In addition to the regular workgroup meetings, DHCD will hold two special full-day meetings for the purpose of reviewing recommended changes from the FSB sub-workgroup to the SFPC edits in Chapters 20-67.

- For the 2018 code development cycle, four specific topics were identified as warranting additional review (Residential Use Groups, Resiliency, Energy and School Safety). The sub-workgroups started meeting in April, reviewing these topics with a goal of identifying and finding consensus on any needed code changes. Sub-workgroup information is available on cdpVA. Next sub-workgroup meeting dates:
  - Residential Use Groups – May 31, 2019
  - School Safety – June 12, 2019
  - Resiliency – July 17<sup>th</sup>
  - Energy – July 18<sup>th</sup>
- At their May 17<sup>th</sup> meeting, the State Building Code Technical Review Board (TRB) issued a formal interpretation of USBC Section 102.3, related to the exemption of wiring and equipment used to provide utility service (and their support structures). The interpretation clarified that the exemption is only applicable to traditional "Electric Companies", and includes solar power generation facilities operated by electric companies. The interpretation further clarified that those items are exempt from the USBC, so long as they do not create an unsafe situation, are located where the utility company has rights of entry and occupancy and the electric company has control of them.
- Every jurisdiction should have also received a Dropbox link to all of the legacy codes, including every referenced model code since the inception of the USBC. If you have not, or if you have problems with retrieving the downloads, please contact Sandi Morris.

- DHCD developed a form for use by landlords related to legislation that was passed last session related to testing of smoke alarms in rental housing. The law became effective January 1, 2019. Please keep in mind, stickers will only be distributed to building officials. To expedite the process, when emailing or leaving a voice message for Nicole, please provide your name, mailing address, and quantity of stickers needed.
- Building Safety Month Proclamation Event was held on May 29<sup>th</sup> at the VCU Institute for Contemporary Art. This year was particular special as this year is the first year that a Governor has been able to attend. Governor Ralph Northam spoke on Virginia being a leader in the development of statewide codes and the importance of the building safety creating resilient communities. The Governor presented the proclamation to the representatives of the stakeholder organizations in attendance. In addition to the Governor Deputy Secretary of Commerce and Trade Cassidy Rasnick and Deputy Secretary Public Safety and Homeland Security Ryant Washington were in attendance.
- The 2019 Building Safety Month Student Essay contest came to a close with a number of thoughtful and well written essays from students representing a variety of high schools, colleges, and home schools in Virginia. The selection committee all agreed on its stand out favorites and were happy to honor the five top essays. Kyle Renaux from Hampton and Grace Beattie from Midlothian High School received first and second place respectively. The honorable mentions were awarded to Arden Floyd from Orange County, Karyah Jones from Harrisonburg, and Nathalie Williams from Keezletown.

The winners were announced during the Proclamation presentation held on May 29<sup>th</sup> at the VCU Institute for Contemporary Art. Governor Northam and DHCD Director Erik Johnston congratulated each student and presented them with certificates.

Over the last couple of months regular announcements and reminders have been going out to the jurisdictions regarding the this year's Building Safety Month Jurisdiction campaign contest. We hope many more localities will submit a summary of their campaign with photos and the many ways they reached out to their communities. Winning jurisdictions will receive a day of DHCD or ICC training of their choice and lunch for their office. Contact Rajan Engh with any questions.

VPMIA Members:

The most recent regulatory amendment to create the Miscellaneous (MSC) Specialty will become effective on August 1. This Specialty license will be for those contractors whose work is extremely limited in scope and that limitation will be described on their license. No type of trades work will be within the scope of the MSC Specialty. Work has begun on amending the contractor's regulations in response to action taken by the recent General Assembly. SB1774 created the fire sprinkler contractor classification by statute, replacing that which the Board had addressed through the regulations. The bill also creates an automatic fire sprinkler inspector certification and requires the Board to promulgate regulations to incorporate the certification as well as continuing education requirements for renewal. A workgroup has met and established a preliminary list of issues to address.

At its June meeting, the Board reviewed the Policies and Interpretations Guidance Document and made some revisions. Although generally editorial, one of the revisions represented a substantive change in application of the regulations to Landscape Service Contracting (LSC). Previously, it was the Board's interpretation that retaining walls covered within the scope of the definition were limited to those with less than three feet of unbalanced fill. A revised interpretation will now permit these contractors to construct residential retaining walls of any height.

The electrical exam offered by the National Association of State Contractors Licensing Agencies (NASCLA) was approved as an alternative to the PSI exam.



A staff member attends randomly selected class presentations and then reports the findings at regular Board meetings along with recommendations regarding responses to the provider. ## **VBCOA/VPMIA 2019 Session LEGISLATIVE COMMITTEE FINAL REPORT (updated 03-29-19)**

Thru- HB2807, HJ734, HR226, SB1786, SJ321, SR99

The legislative committee met via conference call on 22 January 2019. Call participants were: Ron Clements (R6/chair), Julie Walton (R6/chair), Lewis Watts (R4), Paul Messplay (R7), David Beahm (R3), Pet Mensinger (Pres.), Sam Sapienza (R2).

### **HB 1725 Status- Signed into law by the Governor**

**Support-** This is a House Select Committee on school safety recommendation.

*Chief patron: Knight*

**Public school building security enhancements; compliance with Uniform Statewide Building Code and Statewide Fire Prevention Code.** Requires each school board, in consultation with the local building official and local fire marshal, to develop a procurement plan to ensure that all security enhancements to public school buildings are in compliance with the Uniform Statewide Building Code and Statewide Fire Prevention Code.

### **HB 1738 Status- Signed into law by the Governor**

**No Position-** This is a House Select Committee on school safety recommendation.

*Chief patron: Rush*

**School buildings; plans to be reviewed by a professional trained and experienced in crime prevention through environmental design.** Requires the licensed architect or professional engineer who provides the required statement to accompany the school superintendent's approval on all plans and specifications for new or remodeled public school building construction to be trained and experienced in crime prevention through environmental design.

### **HB 1753 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Sickles*

**School buildings; electronic room partitions; safety devices.** Prohibits school boards from installing an electronic room partition in any school building unless such partition includes a contact pressure-sensitive safety edge whereby the partition automatically stops when it senses contact with any object other than the adjoining wall.

### **HB 1776 Status- Died in committee**

**No Position-**

*Chief patron: Cole*

**Prohibition or regulation of Tannerite.** Provides that any locality may by ordinance prohibit or regulate the use of Tannerite or a similar two-component explosive in or near residential areas. Any penalty for an offense pursuant to such an ordinance shall not exceed a Class 3 misdemeanor.

### **HB 1815 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Hope*

**Assisted living facilities; emergency electrical power source; disclosure to prospective residents.** Directs the State Board of Social Services to include in regulations governing assisted living facilities a requirement that each licensed assisted living facility with six or more residents disclose (such) to each prospective resident, or his legal representative, in writing in a document that is separate and distinct from any other documents...

**[HB 1834](#) Status- Died in committee**

**No Position-**

*Chief patron: Marshall*

**Use of binary explosives; penalty.** Creates a Class 1 misdemeanor for any person to combine the components of a binary explosive, defined in the bill, to create an explosive material and ignite more than five pounds of such explosive material at a single time.

**[HB 1949](#) Status- Died in committee**

**[HJ 641](#) Status- Passed House and Senate to study the issue (The VDH sponsored work group met 3-25-19 [Meeting link](#))**

**No Position-** This directly affects Health Department regulations but if passed may require adjustments to USBC plumbing code requirements.

*Chief patron: Webert*

**Rainwater harvesting; water for human consumption.** Requires the Board of Health to include in regulations governing rainwater harvesting systems a provision recognizing rainwater harvesting systems that produce water that meets minimum health and aesthetic standards for pure water adopted by the Board as acceptable sources of water for human consumption.

**[HB 1966](#) Status- Signed into law by the Governor**

**Support (change from oppose) based on acceptance of recommended amendments to lines 103 to 109. VBCOA did not take a position on House and Senate amendments regarding use of permit fees.**

*Chief patron: Yancey*

**Uniform Statewide Building Code; issuance of building permits.** Requires local building departments, when denying an application for the issuance of a building permit, to provide to the applicant a written explanation detailing the reasons for which the application was denied. The bill provides that the applicant may submit a revised application addressing the reasons for which the application was previously denied and that, if the applicant does so, the local building department shall limit its review of the revised application to only those portions of the application that were previously deemed inadequate and that the applicant has revised.

**[HB 2000](#) Status- Died in committee.** The change to the VMC was submitted to the BHCD as an emergency regulatory change, which was approved by the BHCD at the March meeting.

**Oppose as a bill and support as a regulatory change - VBCOA Board voted on 1-25-19 to support Delegate Price as she works through the Governor's office to move this as an emergency regulatory change through the BHCD.**

*Chief patron: Price*

**State agencies; amendment of regulations pertaining to the maximum temperature at which certain rooms may be kept.** Directs the Board of Housing and Community Development to revise the Uniform Statewide Building Code to decrease the temperature at which an owner or operator of certain apartment buildings who rents, leases, or lets one or more dwelling units, rooming units, or guestrooms on terms, either expressed or implied, to furnish cooling to the occupants thereof shall supply cooling during the period from May 15 to October 1 from 80 degrees Fahrenheit to 77 degrees Fahrenheit

### **HB 2045 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Hurst*

**Department of Behavioral Health and Developmental Services; certification of recovery residences.** Provides for the certification of recovery residences by the Department of Behavioral Health and Developmental Services. The bill defines "recovery residence" as a housing facility that provides alcohol-free and illicit-drug-free housing to individuals with substance abuse disorders and individuals with co-occurring mental illnesses and substance abuse disorders that does not include clinical treatment services.

### **HB 2093 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Guzman*

**Virginia Fire Services Board; membership.** Changes the membership of the Virginia Fire Services Board by removing a member of the Virginia Society of Fire Service Instructors and the State Fire Marshal and adding a certified Virginia fire service instructor and a local fire marshal.

### **HB 2101 Status- Died in committee**

**No Position-** JLARC recommendation

*Chief patron: Freitas*

**Department of Professional and Occupational Regulation; deregulation of the practice of landscape architects, soil scientists, and waste management facility operators.** Implements the recommendations of the Joint Legislative Audit and Review Commission in its report on Operations and Performance of the Department of Professional and Occupational Regulation by eliminating licensure requirements for landscape architects, soil scientists, and waste management facility operators.

### **HB 2229 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Bagby*

**Affordable housing; waiver of fees.** Provides that a locality may by ordinance provide for the waiver of building permit fees and other local fees associated with the construction, renovation, or rehabilitation of housing by a private-sector entity that is pursuing an affordable housing development.

### **HB 2327 Status- Signed into law by the Governor**

**Support-** Gives DPOR the authority to take action against people and companies contracting without a license.

*Chief patron: McNamara*

**Department of Professional and Occupational Regulation; unlicensed practice; cease and desist notices.** Permits the Director of the Department of Professional and Occupational Regulation, or his designee, to issue a notice to any person unlawfully engaging in unlicensed practice of an occupation to cease and desist such activity.

### **HB 2364 Status- Died in full House vote**

**No Position-** Does not appear to have building or fire prevention code implications.

*Chief patron: Knight*

**Agritourism; weddings.** Amends the definition of "agritourism activity," for purposes of liability as well as the statutory limit on the imposition of restrictions by local governments, to include service as a wedding venue for not more than 12 weddings per calendar year, each wedding involving not more than 250 guests.

### **HB 2724 Status- Died in committee**

**No Position-**

*Chief patron: Helsel*

**Uniform Statewide Building Code; rental inspection districts; inspection of residential rental dwelling units.** Permits a local building department in a locality that has established a rental inspection district to choose to delay the initial inspection of dwelling units until the first time the units become vacant on or after the establishment of the district, unless an earlier inspection is requested by the owner or a tenant.

### **HB 2756 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Miyares*

**Child day programs; licensure exemption.** Exempts from licensure any child day program in which child-minding services are offered on site by a small business to no more than five children at any given time, provided that the parent or guardian of every child is an on-duty employee of the small business and can resume responsibility for the child's supervision within 30 minutes upon request.

### **SB 1077 Status- Signed into law by the Governor**

**No Position-** The current law requires assisted living facilities to provide a generator by July 1, 2007. This bill updates the law by removing the compliance date. The bill also specifies what the generator must power at a minimum.

*Chief patron: Howell*

**Assisted living facility; temporary emergency electrical power source.** Requires licensed assisted living facilities with six or more residents to have a temporary emergency electrical power source available on site and to be able to connect to and utilize such power source for the provision of electricity during an interruption of the normal electric power supply.

### **SB 1229 Status- Died in House Committee**

**No Position-** we worked with Senator Ebbin to amend the bill text from “promulgate code” to “receive and consider” a code change to include trampoline parks in the VADR. We agreed to submit the code change in cdpVA on Ebbin’s behalf.

*Chief patron: Ebbin*

**Board of Housing and Community Development; amusement devices; trampoline courts.** Directs the Board of Housing and Community Development to promulgate regulations pertaining to the construction, maintenance, operation, and inspection of amusement devices known as trampoline courts pursuant to its current authority to regulate amusement devices.

### **SB 1535 Status- Died in House Committee**

**No Position (prior opposition) based on the bill being amended per our request-** VDOT has asked for our input, which will be provided.

*Chief patron: Surovell*

**Uniform Statewide Building Code; outdoor advertising.** Requires the owner of a sign located along an Interstate System highway that has a height that is greater than the distance from such sign to the shoulder edge of the pavement to have such sign periodically inspected for building code compliance. The bill authorizes the Commissioner of Highways to remove any such sign without notice and at the cost of the owner if the sign poses a risk to highway safety or public safety.

### **SB 1625 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: McPike*

**Statewide Fire Prevention Code; definition of permissible fireworks.** Changes the definition of permissible fireworks to mean any fireworks device that (i) does not explode or produce a report, (ii) does not emit visual effects to a distance greater than 16.4 feet, (iii) does not produce a continuous flame longer than 20 inches, (iv) does not travel under its own power, (v) does not emit or function as a projectile, and (vi) is not capable of being reloaded.

### **SB 1701 Status- Died in House Committee**

**No Position-** Simply states inspections shall comply with USBC.

*Chief patron: Ebbin*

**Regulation of short-term rentals; urban county executive form of government.** Requires any ordinance adopted by the governing body of any county that operates under the urban county executive form of government (Fairfax County) relating to regulation of short-term rentals to comply with various provisions related to the short-term rental of property, including limits on (i) the total number of nights permitted for short-term rental on the short-term rental operator's property and (ii) the number of short-term rental properties owned by any one person or entity. The bill also requires such ordinance to comply with various Code of Virginia provisions related to zoning enforcement, the Virginia Uniform Statewide Building Code, real estate licensing, common interest communities, and covered entities otherwise regulated by localities.

### **SB 1755 Status- Signed into law by the Governor**

**No Position (prior opposition) based on the bill being amended per VFPA request. The bill now requires DHCD to facilitate a work group to discuss this issue during the next code update cycle. VBCOA needs to be involved.**

*Chief patron: Hanger*

**Board of Housing and Community Development; Uniform Statewide Building Code; Statewide Fire Prevention Code; use of temporary barricade devices in classrooms.** Directs the Board of Housing and Community Development to revise the Uniform Statewide Building Code and the Statewide Fire Prevention Code, as appropriate, to permit the use, by a staff member of a public or private elementary or secondary school or public or private institution of higher education, of a temporary barricade device on the door of a classroom or any other area where students are located for a finite period of time during an active shooter emergency or active shooter drill. The bill specifies several requirements for the use of such devices.

### **SB 1774 Status- Signed into law by the Governor**

**No Position-**

*Chief patron: Edwards*

**Board for Contractors; requirements for licensure; certification of automatic fire sprinkler inspectors.** Creates the classification of fire sprinkler contractor for the purpose of licensure by the Board for Contractors (the Board). The bill also creates a certification for automatic fire sprinkler inspectors and prohibits any person from conducting inspections of automatic fire sprinkler systems unless he maintains or is accompanied by a person who maintains a Level III or higher NICET certification. The bill requires the Board to promulgate regulations requiring continuing education and knowledge of the Statewide Fire Code as prerequisites for certification renewal as an automatic fire sprinkler inspector. The provisions of the bill mandating NICET certification have a delayed effective date of July 1, 2021.

Greetings Board members,

Since my last report, the /VPMIA/VBCOA PMG Committee (consisting of 33 active members!) has been very busy working on the 2018 Virginia Regulatory Code Development process by conducting multiple internet-based meetings to discuss possible VPMIA/VBCOA endorsed code change proposals to the International Residential Code, International Plumbing Code, International Mechanical Code and International Energy Conservation Code. The following proposals are the results of the committee recommendations for submittal on behalf of VPMIA/VBCOA:

1. RE 403.3.1 Insulation (Ducts)
2. RE 403.3.5 Building Cavities
3. RTP 3011 and TP717 Relining of Building Sewers and Building Drains
4. TM 506.5.6 Pollution Control Units
5. TP 202 Service Sink Definition
6. TP 410 Substitution
7. TP 605.2.1 Lead Content of Drinking Water Pipe and Fittings
8. TP 608.13.6 Atmospheric-type Vacuum Breakers
9. TP 608.16.7 Chemical Dispensers
10. TP 705.11.2 Solvent Cement
11. TP 1101.7 Roof Design
12. TP 1105.2 Roof Drain Flow Rate
13. TP 1110 Equivalent Roof Area
14. TP 1301.1 General (Rainwater Harvesting Alternative)

Workgroup 3, scheduled for May 15, 2019 was cancelled due to an insufficient number of submitted proposals and was combined with Workgroup 4, scheduled to meet June 5, 2019.

Workgroup 3/4 met as scheduled and included a number of VPMIA/VBCOA PMG Committee member participants. I want to extend a gracious “Thank You !” to all who attended.

The next Workgroup 3/4 meeting is scheduled for August 21, 2019.

The result from this workgroup meeting for the VPMIA/VBCOA proposals are as follows:

- Numbers 1 and 2 were “tabled,” along with five other energy related proposals in order to get feedback from the Energy Workgroup scheduled to meet July 18, 2019. These proposals will be heard again during the next Workgroup 3/4 meeting.
- Numbers 3, 4, 7, 10, 11, 12 and 13 all received consensus from the group.
- Number 5 had a processing issue that prevented it from making it on the agenda. This proposal will be heard again during the next Workgroup 3/4 meeting.
- Number 6 needed further review and perhaps some wordsmithing in order to receive consensus. The feel of the group was that they were in favor of the concept, but the language submitted did not achieve the desired results. This proposal will be heard again during the next Workgroup 3/4 meeting.
- Numbers 8 and 9 received non-consensus.
- Number 14 received overall consensus, however it was “tabled” in order to provide an opportunity to address mild concerns expressed by a member of the Virginia Department of Environmental Quality. This proposal will be heard again during the next Workgroup 3/4 meeting.

Currently, the committee has only one more proposal to submit related to a kitchen hood exhaust flow rate conflict between the International Mechanical Code and the International Energy Conservation Code. This proposal was not completed prior to the May 28, 2019 submission deadline for the June 5, 2019 Workgroup 3/4 meeting. It is my intent to submit this proposal for review by the Energy Workgroup prior to the August 21, 2019 Workgroup 3/4 meeting.

Finally, I am saddened to report that one of our distinguished committee members in attendance spoke in opposition to the PMG Committee's recommendations on at least two accounts during the workgroup meeting, resulting in a "non-consensus" determination based on DHCD's 100% consensus policy. Non-consensus proposals do not move forward for any further discussion.
