12/3/2022 Meeting Minutes

President Ellis McKinney begins the meeting with the Pledge of Allegiance.

Ellis McKinney states we had a successful VA Governors Housing Conference. It was well attended and it was an opportunity to get out there and represent the VPMIA.

Mr. President asks the Secretary Dennis Hart whether we have a quorum. Quorum was established. Motion was made to approve meeting meetings which was seconded and approved.

Treasurers Report – Treasurer spoke on his submitted report. Fred Crowell, the treasurer stated he was having issues with the ICC and renewing our preferred provider status. It appeared to be a merchant issue and not an issue with the bank but may be a software issue. The treasurer is waiting for an invoice so the bill can be paid. Anthony McMahan states both Mr. Crowell and Mr. Martin attempted to pay online with their credit cards, but it did not work. Dennis Hart asks if a check can be sent, and Mr. Crowell said he will inquire.

Secretary Report – Meeting Minutes were submitted and approved, otherwise no report.

Executive Secretary Report – The State Corporation Commission has been paid, otherwise please see previous report from previous BOD meeting.

ICC – Cindy Davis speaks for ICC. Asks that we remind everyone in our offices about the Emory Rodgers Scholarship. The deadline is December 31st and involves a 20k reimbursement for a leadership camp. On December 7th, ICC is holding a discussion on inspection safety issues regarding existing buildings. This was because of the Surfside Collapse in Miami.

Region 7 – No report, scheduled to meet in January.

DHCD – Cindy Davis speaks on the hiring of several new staff members. Sandy Morris adds that NCPCCI and their relationship with Prometric is terminated at the end of 2021. They are contracting with another provider, but not all the details are worked out. As of now, only ICC exams are available in Virginia after December 31st, 2021.

Mr. President states Vernell Woods is liaison for DPOR – Ellis states Mr. Woods has nothing to report from DPOR and will be able to give an updated report after the holidays.

Ellis McKinney starts the discussion on the yearbook. Says he met with Anthony McMahan, Vic Hines, and Jane Fitzgerald regarding the yearbook. Anthony informs the board that Jane is going to design the yearbook. She has requested that we get together materials, such as pictures and technical articles. Mr. McMahan suggests we try to limit advertisements and have more content and take more of a loss than we normally do to produce the yearbook to commemorate our 60th anniversary. A point is made to the board that we should reach out to membership for content and that pictures should be of a high quality. Ellis McKinney agrees with Anthony to limit advertisements and have more content to commemorate the 60th anniversary. Ellis wants us to use the advertisers who have always supported us in the past. The next Yearbook Committee meeting will be in early January. Mr. McKinney thanks Jane, Vic and Anthony for coming on board to help with the production of the yearbook.

Mr. McKinney shifts gears to the Spring SOI in Virginia Beach. Makes note that the contract has been signed with the hotel and we are moving ahead with the in-person conference. There is a discussion on providing gifts to members for the SOI. Ellis McKinney will take the lead on gifts for members.

Mr. McKinney inquiries about ideas on how to get membership to grow? Vic Hines suggests half price membership fee for new members. Ellis suggests sending an open letter to members to encourage recruitment. Richard Grace suggests free registration for anyone who joins and volunteers to serve as a co-chair on a committee.

The next BOD meeting is planned for February 11th.

December 15 – Ellis McKinney will represent VPMIA in the Virginia residential sprinkler discussion.

Tom Clark follows up on old business and suggests cancelling the MS Teams subscription. States it was primarily used for the virtual SOI due to COVID and it is not needed at this point. Mr. Clark motions to delete the MS Teams account which was seconded. BOD approved motion.

Richard Grace speaks on Pexal pipe which the manufacturer is promoting for use in the Commonwealth. This is plastic gas piping and is not permitted by code. Mr. Grace sent information via email to the BOD for review and suggests a letter to membership stating that VPMIA does not believe this product is compliant with code. After discussion, the BOD will review the information and discuss further.

VPMIA/VBCOA PMG Committee – Vice-Chair Dennis Hart speaks on the results of the 2024 I-Codes Group A proposals. Of the proposals that VPMIA had a position on, the VPMIA had a 66 percent success rate. Report is attached.

VBCA Activity Report – Sandi Morris, DHCD

Sandi Morris provided an overview of academy activities for 2021. The attached report was provided to BCAAC members in attendance.

Staffing update – Sandi Morris

Over the summer Kelly Duggins left the code academy to take a curriculum development and instructor position with the VA Retirement Services; and Danielle Manuel accepted a new position within DHCD as an HR recruiter.

The VBCA has hired two new training coordinators, both with extensive experience in coordinating training and event planning. Starting in October Krista Artis comes to us from the Chesterfield County School System where she handled facility management, rentals, and employee training. Katy Yuan served as the training coordinator for the Irrigation industry planning and coordinating training for the industry stakeholders and will start in November.

Fire Prevention Inspector certification update – Sandi Morris

Staff from both the VBCA and State Fire Marshal Academy (SFMA) worked cooperatively to address the ongoing confusion on continued education requirements for those having completed the 1031 course and hold the fire prevention certification. SFMA will update their webpages and policies to reflect those holding the DHCD Fire Prevention Inspector certification need to refer to the DHCD continuing policy and those having completed the 1031 need to refer to their AHJ for continuing education requirements.

The VBCA and SFMA staff dedicated much discussion establishing a path to certification for those not requiring fire marshal powers. With the support of the BHCD and VDFP a second path for Fire Prevention Inspector certification is now available to those candidates seeking Fire Prevention Inspector certification that will not be seeking appointment as a Fire Marshal in accordance with Chapter 3 of Title 27 of the Code of Virginia (§ [27-30](#) or § [27-36](#)). Applicants not seeking appointment as a Fire Marshal or Assistant Fire Marshal and who do not wish to attend the VFMA 1031 Fire Inspector course, may utilize the alternative path to Fire Prevention Inspector certification. Applicants choosing the alternative path will attend the DHCD Core class followed by the completion of the VFMA Fire Inspector Bridge class.

The ICC exam #66 Fire Inspector I and the ICC exam #67 Fire Inspector II, which are both based on the 1031 JPRs, is required for candidates using this path for certification. Once having attended the required courses and passed the required exams, certification applications are submitted to DHCD.

Certification Guide review

BCAAC members reviewed the current Code Officials Certification Guide (formally known as the matrix) and agreed a number of updates to certification requirements may be order. The committee will review the certification guide providing feedback to Sandi Morris for BCAAC review at its next meeting.

Initial comments included:

As a whole the committee is very happy with the progress of the trades' classes separation into residential and commercial content.

Would like to revisit the accessibility certification discussion

Has the time to come to move the energy certifications from an optional cert to a mandated certification or at least adding the class to specific certifications.

Code Development Update – Paul Messplay, DHCD

Core Redevelopment – Rajan Engh, DHCD

Rajan Engh, development specialist, provided members with an update on the Core redevelopment progress and revised release schedule (attached) to the BCAAC members. Major points of redevelopment include:

- Specific topic areas have been identified for self-paced modules to be provided through the Learning Center as a pre-requisite to attending the classroom portion of the training. All suggestions combined will be about 2.5 hours and all Core participants will be notified of requirement and staff will set up a tracking and reminder system to ensure all students complete the prerequisites. Chair Snidow fully supports the prerequisite session content and process
- Revised core relaunch dated pushed to November 2021.

NCPCCI update – Rajan Engh and Sandi Morris

Rajan Engh was recently elected to the NCPCCI vice president position on their Board of Governors. After many years using Prometric to provide exam development, item bank oversight, and exam administration they have decided to terminate their relationship with NCPCCI.

NCPCCI is in the process of securing services with PROV. Prov uses local community colleges as testing centers.

Chair Snidow recommended the establishment of an NCPCCI residential plan review exam
