Earlier in the year we purchased a new laptop to replace our original laptop used by the webmaster and while I hoped this new computer would run the software I have used for the site since 2009 it was not compatible. We have had much discussion about the Secretary having a laptop and I would like to suggest this computer be given over to the Secretary at our February meeting.

I had to contact the time clock plus support team to assist with installing that old software onto this new computer and it is up and running. The difference in the computers is that nowadays computers run on 64 bit system and the website software is only compatible on a 32 bit system. The organization has been paying for 1 ½ years now roughly 800.00 a year for internet access in my home to maintain the website. A trip down memory lane reveals prior to my going to work for the State Louisa County provided me with the internet access because we did inspections from our vehicles and needed the hot spot which was a flat fee for unlimited data usage, hence, it was a free service provided by the County.

The organization has a decision to make and that is do you want to invest in a rebuilt dell 32 bit computer that will hopefully work the old software and continue to use the hot spot provided to me and I will continue to maintain the website?

Other options are someone take the site over and rebuild it using todays free web design tools; or find a company to maintain the site for a fee. Our contract with Verizon renews in February so we should make this decision by then.

Whatever is decided I am fine with but please know that at the end of the 2016 SOI my website duties will be like it was when I started which was send me stuff to post and I will post it.

Also please note the pay pal account has been closed which was under VPMIA but in my name and once the tax exempt status is resolved the account can be created new and I suggest it be in the name of the Executive Secretary. I have copies of every transaction that was made while VPMIA had the pay pal account.

On October 9th we were scheduled to use our 2015 chapter education voucher with the Region 1 membership and the class was 2012 IBC Building Classification Presentation held in Abingdon, VA. We had 35 attendees in the group however the instructor had to cancel the class at that last minute due to a sudden illness. The ICC has assured me that this class will be made up (Nov 12) and have also offered another training day session to be used next April, also in Region 1. I went down the day before and originally planned on staying two nights however I came back home the following day and am requesting a reimbursement for the one night hotel stay.

On November 4th Richard and I will be doing 2012 code update training for the City of Alexandria for a flat fee to an estimated 75-150 attendees.

The 2016 SOI training will consist of 4 classes on Wednesday with one of those slots taken (possibly 2) and Thursday we will use our 2016 chapter education voucher from ICC and the class will be 2015 PMG significant changes.

Please note at the end of the 2016 SOLI will be removing myself from this committee so Mr. Grace you will need to find a chair and I will share all the DHCD, DPCR, and ICC Preferred Provider instructions with my replacement.

Legislative Report for VPMIA

October 29, 2015

I received no response from our question circulated regarding prosecution of building code violations when the case was taken to court within the SOL but ownership changed after the SOL expired. This was the issue that Henrico has been experiencing within their courts. Based on the lack of other localities having a similar experience I don't see us moving forward with any legislative solution at this time.

It was brought to our attention from Mark Flynn with VML that there is a move to remove the protection for complainants of code violations provided in Virginia FOIA statute 2.2-3705.3. Joel and I will be working to oppose this move. At this point it is a discussion in the FOIA commission and no bill has been drafted.

Our lobbying firm Kemper has been listed as the number one small lobbing firm in Virginia.

Board for Contractors Report to the VPMIA Board of Directors

Several regulatory packages were recently approved by the Governor and will become effective on January 1. Among them are revisions which serve to reaffirm existing requirements in the Individual License and Certification Regulations to maintain continuing education requirements for tradesmen. As you know, there was considerable discussion and public comment generated by this proposal which ultimately resulted in the Board for Contractors revising the previously proposed language that would have eliminated the requirement. Subsequent to the reversal, a workgroup developed recommendations to improve the program and those recommendations will be part of the Board's activity in the coming months as staff prepares and presents suggested improvements for consideration.

Additional changes approved in their final form involve licensing of Residential Building Energy Analysts (Individuals and Firms), the splitting of building contractors into residential and commercial classifications and an extension of the timeframe in which an expired license may be reinstated from one year to two years. In the proposed stage are amendments to add more specific classifications and specialties including drywall, finish carpentry, tile and underground utility contracting.
